Management Discussion and Analysis

The following discussion and analysis should be read in conjunction with the unaudited condensed interim consolidated financial statements for the period ended July 31, 2022, and related notes included therein, prepared in accordance IAS 34, Interim Financial Report (“IAS 34”), as issued by the International Accounting Standards Board (“IASB”), and its interpretations, using accounting policies consistent with International Financial Reporting Standards (“IFRS”). All monetary amounts, unless otherwise indicated, are expressed in Canadian dollars. Additional regulatory filings for the Company can be found on the SEDAR website at www.sedar.com. Northern Lights Resources Corp. (the “Company” or “Northern Lights”) was incorporated under the laws of British Columbia on March 28, 2007. The Company’s principal business activities include the acquisition and exploration of resource properties. On December 31, 2020, the Company began trading of its common shares on the OTC Venture Market under the symbol “NLRCF”.

Overview and Going Concern

The Company is in the business of acquiring exploration and evaluation assets. The Company was listed and began trading on the CSE under the symbol “NLR” October 2018. On February 1, 2021 the Company received DTC and Blue Sky clearance trading on the OTC QB under the symbol “NLRCF”.

The Company currently has negotiated two property agreements, a earn-in-agreement on our Medicine Springs high grade Silver, Lead and Zinc property in Nevada and the purchase of a 100% interest in the Secret Pass Gold Property in Arizona.

The Secret Pass Gold property consists of 868 hectares located in the heart of the Historic Oatman-Katherine gold mining district in northwest Arizona. This historical mining district produced 2 million ounces of gold and 1,000,000 ounces of silver between 1892 and 1940 at an average gold grade of over 15 g/t.

The Medicine Springs property located on the eastern edge of the Carlin Trend in southeastern Elko County, consists of 149 unpatented Federal mineral claims covering 1,189 Ha located in the Ruby Mountains Valley. The Medicine Springs property is a high grade Silver-Zinc-Lead project with significant potential to host a large scale high-grade Carbonate Replacement Deposit (“CRD”) deposit. (“*see mineral property agreements*” below)

The Company’s ability to continue as a going concern is dependent on its ability to raise additional funds through equity issuances. These events and conditions indicate a material uncertainty which may cast significant doubt on the Company’s ability to continue as a going concern.

The condensed interim consolidated financial statements for the period ended July 31, 2022 were prepared on a going concern basis which assumes that the Company will be able to realize its assets and discharge its liabilities in the normal course of business for the foreseeable future. The continuing operations of the Company are dependent upon its ability to continue to raise adequate financing and to commence profitable operations in the future. The consolidated financial statements do not include any adjustments relating to the recoverability and classification of recorded assets and liabilities that might be necessary should the Company be unable to continue as a going concern.

In March 2020, the World Health Organization declared coronavirus COVID-19 a global pandemic. This contagious disease outbreak, which has continued to spread, and any related adverse public health developments, has adversely affected workforces, economies, and financial markets globally, potentially leading to an economic downturn. It is not possible for the Company to predict the duration or magnitude of the adverse results of the outbreak and its effects on the Company’s business or ability to raise funds.

Results of Operations

The results of operations reflect the overhead costs incurred by the Company to maintain good standing with the various regulatory authorities and to provide an administrative infrastructure to manage the acquisition, and financing activities of the Company. General and administrative costs can be expected to increase or decrease in relation to the changes in activity required as property acquisition continues. The Company has not recorded, since the date of its incorporation, any revenues from its mineral exploration and development activities, nor does it expect to record any revenue over the course of the next 12 months.

Mineral Properties

i) Medicine Springs Property

The Company entered into a mineral property option agreement dated August 20, 2017 to acquire 100% of the property in southeastern Elko County, Nevada.

The option agreement is a 6 phase exploration agreement. Completion of all of the phases under the agreement is subject to staged cash payments of \$950,000, equity consideration of USD \$250,000 and incurring exploration expenditures of USD \$2,700,000. The agreement was amended in July 2020 to extend certain due dates.

The Company has the option to proceed with each subsequent Phase in the Option Agreement upon the completion of all cash and equity consideration payments to the vendors in addition to meeting the minimum exploration expenditure payments defined for each Phase of the Option Agreement.

- d) NSR
- The mineral claims comprising the Property, are subject to a 2% Net Smelter Royalty (‘NSR’) with an additional 0.5% NSR applicable to the 123 claims previously owned by Newmont Mining Corporation.
- e) Exploration expenditures – completed as of April 30, 2022
- i) the Company incurred US\$24,887 of expenditures by making payments: (i) US\$23,095 to the United States Department of the Interior Bureau of Land Management, and (ii) US\$1,792 to the Elko County Recorder’s Office for 2017 taxation year.
 - ii) the Company incurred US\$25,093 of expenditures by making payments: (i) US\$23,195 to the United States Department of the Interior Bureau of Land Management, and (ii) US\$1,898 to the Elko County Recorder’s Office for 2018 taxation year.
 - iii) the Company has paid the cash option payment of US\$25,000.
 - iv) the Company incurred US\$183,193 (C\$231,345) of exploration expenditures as of April 30, 2021 on the Medicine Property.

In addition, the property owner will retain a 2.5% NSR. The Company has the option to purchase back 1.5% of the NSR for US\$3,000,000 on a portion of the mineral claims (126/149) and US\$1,000,000 on a portion of the mineral

claims (23/149). The royalty to the project vendors is in addition to a further 0.5% royalty over a portion of the mineral claims (23/149).

The Company has entered into a Property Option and Joint Venture Agreement (the “Agreement”) with Reyna Silver Corp. (“Reyna Silver”).

Under the terms of the Agreement, Reyna Silver can earn a 75% interest in the Medicine Springs property by assuming and satisfying certain of the Company’s commitments in the underlying option agreement dated August 20, 2017. Specifically, by paying US\$ 875,000 and incurring exploration expenditures of approximately US \$2,400,000 by December 31, 2023, of which US \$700,000 needs to be spent by December 31, 2021. Reyna Silver can earn an additional 5% can be earned by making a cash payment of US \$1,000,000 to the Company by no later than December 31, 2023.

Upon completion, the Company and Reyna Silver will jointly own 100% of the Medicine Springs and will establish a joint venture.

On January 12, 2022, the Company announced the assay results from a jasperoid rock sampling program completed at the Medicine Springs Silver project that the Company is exploring in joint venture with Reyna Silver Corp.

Medicine Springs hosts Carbonate Replacement Deposit (CRD) mineralization exposed at a very high level marked by well-developed multi-stage NE-SW trending jasperoidbarite veins within an area of approximately 6 km x 6 km. These veins extend well beyond the areas of historic small-scale mining and very shallow drilling, so Reyna sampled them systematically to determine if a mineralization center or centers could be defined.

Systematic sampling (657 samples) of these veins throughout a 6 by 6 km area returned very strong results for Silver with 37 samples returning over 66 g/t Ag, 2 samples returned assays of over 1,000 g/t Ag. Assays for lead, zinc and copper showed anomalous results along a prominent NE-S trending structural network.

On September 12, 2022, the Company announced that drilling is scheduled to commence mid-September at the Company’s Medicine Springs Silver Project (“Medicine Springs”), located in Elko County, Nevada.

Drill permits have been received and a drilling contractor has been appointed. An initial 4,000 metres of diamond core drilling is planned to be completed at Medicine Springs over the next few months. Initial drill targets include Golden Pipe, Silver Butte and Silver King. This first drilling campaign will test the structural framework and mineralization of a potential large scale Carbonate Replacement Deposit at Medicine Springs. Historic drilling at Medicine Springs is limited to shallow reverse circulation drilling (average depth 125 metres) that was conducted around Golden Pipe in the 1980’s. The historic drilling at Golden Pipe was focused on near surface oxide mineralization. This will be the first time that project is being drilled with the focus on defining a large scale Carbonate Replacement Deposit that NLR first identified the potential of through exploration work including geophysics, structural mapping, and a mobile metal ion soil geochemistry soil survey. (See Figure 1)

Carbonate Replacement Deposits (CRDs) are high-grade, sulfide-rich, polymetallic (Ag-Pb-Zn-Cu-Au) systems that form through repeated reactions between magma-driven hydrothermal fluids and carbonatedominant wall rocks. Their high multi-element grades and potentially large size make CRDs attractive exploration targets.

The drilling campaign at Medicine Springs is being completed by Reyna Silver (TSX.V RSLV) as operator under the terms of the Medicine Springs Option/Joint Venture Agreement. Reyna Silver can earn up to 80% of the Medicine Springs project by making certain exploration expenditures and cash payments. Northern Lights has a free carried interest until Reyna Silver has expended a minimum of US\$4.0 million dollars on exploration at Medicine Springs. See the NLR announcement dated October 5, 2020 for full details of the Option/Joint Venture Agreement between NLR and Reyna Silver.

Medicine Springs shows most of the key features of large-scale CRDs, especially the three most important factors: location, structure, and grade.

1. Location - Medicine Springs lies within a well-known mineralized belt that includes the nearby Ely and Eureka Mining Districts famous for both CRD and Cu-porphyry deposits. 2. Structure - Medicine Springs is hosted very high in the regional carbonate stratigraphy meaning a considerable thickness of favorable host rocks underlies the district. 3. Grade - Medicine Springs shows high (>400 g/t) silver grades in jasperoid and mineralized outcrops, as well as in historic shallow reverse circulation drillholes in the oxide zone.

ii) **Secret Pass Gold Project**

During the year ended April 30, 2020, the Company entered into a purchase agreement to acquire a 100% interest in the Secret Pass Gold Project located in northwestern Arizona.

Pursuant to the option agreement, the Company agrees to make the following consideration payments:

- a) within 5 working days following the exercise of the option, the Company will pay cash consideration of US\$75,000 (paid);
- b) within 30 days following the exercise of the option, the Company will issue 2,000,000 common shares (issued and valued at \$80,000); and
- c) under the terms of the agreement, the Company will make the following additional payments:
 - i) US\$175,000 on or before September 20, 2019 (paid); and
 - ii) US\$125,000 on or before November 8, 2019 (paid).

There are no third-party royalties payable on future production from the project.

As of November 7, 2019 the Company was pleased to announce that it had completed the cash consideration payments to the Project vendors totaling US\$350,000 as defined under the definitive purchase agreement for the Transaction announced by the Company on July 15, 2019, issued 2,000,000 common shares to the Project vendors and completed other administrative arrangements required to complete the Transaction. The Company has renewed its exploration licence on the Secret Pass Gold Property for 5 years and completed preliminary exploration work in preparation for exploration drilling.

On March 26, 2020 the Company completed the change of registration for the mineral claims acquired under the Secret Pass Gold Project ("Secret Pass") acquisition announced on July 15, 2019. Northern Lights was notified by the State of Arizona Department of Land that as of February 12, 2020, the 84 mineral claims (comprising 868 hectares) associated with Secret Pass are 100% owned and registered in the name of Northern Lights' wholly owned, Arizona registered, subsidiary company Secret Gold Pass LLC.

In September 2020 an airborne geophysics survey over the entire Secret Pass Gold Project was completed. The geological information gathered from the airborne survey along with additional geological studies will provide data to select the best possible drill targets available. The Tin Cup Gold Zone is an initial priority for the Company's exploration work at Secret Pass. The Tin Cup zone accounts for less than 10% of the total license area.

In September 2020 the Company strengthened its Geological team for exploration work on the Secret Pass Gold Property (Arizona) and the Medicine Spring Property (Nevada) with the addition of Mr. Paul Warren (P.Geol) and Mr. William (Bill) Tafuri (P.Geol).

On October 26, 2020, the Company announced an 8 hole 1,600 meter drill program at Secret Pass with drilling to commence upon receiving required permits from Arizona State and the Federal Bureau of Land Management.

On December 1, 2020, the Company completed a reinterpretation and review of Induced Polarization (IP) and Resistivity Survey data that was initially collected by Santa Fe Mining in 1992. This work identified over 20 new exploration targets in previously unexplored areas of the Secret Pass mineral claims.

On March 31, 2021, the Company announced it has received approval from the US Bureau of Land Management to commence drilling at the Secret Pass Gold Project in Mohave County, Arizona.

On April 6, 2021, the Company announced the results from a stream sampling program at Secret Pass Gold Project in Mohave County, Arizona.

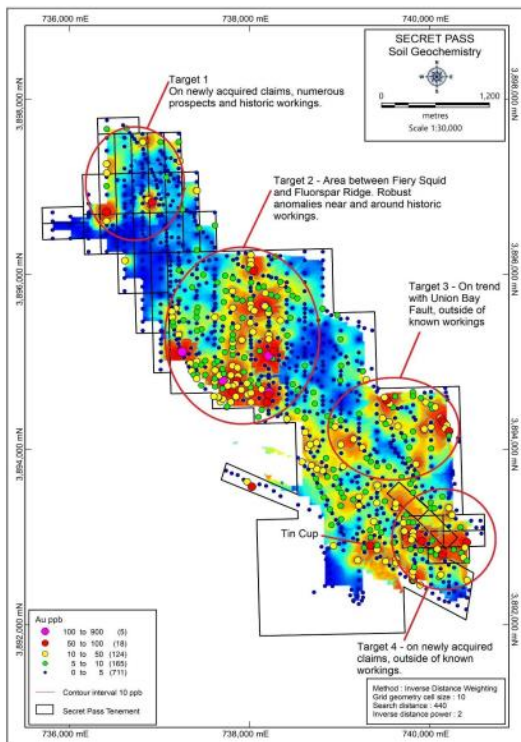


Figure 1: Secret Pass Project - Exploration Target Areas

Northern Lights completed a property-wide stream sampling program comprising 196 stream sediment and 196 panned concentrate samples. With reference to Figures 1 and 2, the anomalous assays define 3 areas centred on the Fiery Squid, Tin Cup and Lion's Paw prospects. In total, 35 samples returned assay gold grades above 0.2 g/t including assays of 30.6 g/t and 6.7 g/t collected downstream from the Tentacles and Fiery Squid prospects. Drilling is planned to commence immediately at Tentacles and Fiery Squid.

On April 15, 2021, the Company announced that drilling has begun at its Secret Pass Project in Mohave County, Arizona.

On May 5, 2021, the Company announced visible gold ("VG") has been intersected in the first drill hole completed at the Fiery Squid prospect at the Secret Pass Gold Project in Arizona.

On June 8, 2021, the Company announced that it has received approval from the Arizona State Land Department to commence drilling at the Tin Cup Prospect at the Company's Secret Pass Gold Project in Mohave County, Arizona. Northern Lights began drilling at Secret Pass on April 15 and is now completing the 4th drill hole (total approximately 600 metres) out of the total 22 permitted drill holes located on mineral claims registered with the US Bureau of Land Management. The prospects drilled included Fiery Squid, Nine Second Shaft and Fluorspar Ridge locations. All drill core has been split and sent to Skyline Laboratories in Tucson, assays are pending.

On July 13, 2021, the Company announced it has completed 4 drill holes (2 holes at the Fiery Squid Prospect, 1 hole at the 9 Second Shaft Prospect, 1 Hole at the Fluorspar Ridge Prospect) for a total of 600 metres of HQ core. The assays are pending and are expected to be completed during July 2021.

Permits are in place to drill at Tin Cup. Drilling at Tin Cup has been put on hold for a couple of weeks during the current period of extremely hot weather in Arizona and Nevada with temperatures averaging +40 degrees celsius. Drilling at Tin Cup is to commence in mid-July 2021.

On September 30, 2021, the Company increased the total leased mineral claim area at Secret Pass project in Mohave County, Arizona by 30%.

The Company has completed the registration of 32 new mineral claims with the US Bureau of Land Management comprising 260 hectares. The additional claims increase the area of the Secret Pass Project to approximately 1,128 hectares.

On November 12, 2021, the Company announced that it has commenced core drilling at the Tin Cup prospect at the Secret Pass Gold Project in Arizona.

Godbe Drilling have been appointed as the drilling contractor. Drilling on the first hole (TC21-02) at Tin Cup began on Wednesday, November 11.

On December 16, 2021, the Company announced the completion of the initial drill program at the Tin Cup.

On January 10, 2022, the Company announced the results from the mobile metal ion (MMI) soil geochemistry survey completed at the Secret Pass Gold Project.

The results of the MMI soil survey (1,139 soil samples), when interpreted with the geology, alteration and geophysics data, define four new significant mineralization target areas outside of the Tin Cup Zone as illustrated in Figure 1.

Two of the highlighted target zones include, Target 1 and Target 4 are on newly staked mineral claims announced by Northern Lights on September 30, 2021.

Targets 2, 3, and 4 are considered to be a priority for detailed geological mapping and sampling to identify future drill targets.

Target 1 on newly acquired claim areas in the northwest quadrant of the project tenements defined a gold in soil anomaly including samples of up to 51.6 ppb Au.

Target 2 is centred on the area between the Fiery Squid and Fluorspar Ridge defining a 1.9 km N-S trending gold in soil anomaly that lies between the Union Pass and Frisco Mine Faults. Results include samples of up to 547 ppb Au. Target 3 in an area adjacent to Union Pass Fault defined a gold in soil anomaly that is outside known workings on trend with previous prospects and drifts. Includes samples of up to 95.4 ppb Au.

Target 4 on newly acquired claim area that includes numerous shallow shafts and surface workings form two subparallel vein systems. No surface rock sampling was previously undertaken in this area. The results show gold in soil anomaly including samples of up to 86 ppb Au.

On February 22, 2022, the Company announced the assay results from the first two drill holes (TC21-02 and TC21-03) completed at the Tin Cup prospect.

Assays received for TC21-02 and TC21-03 indicate wide zones of near surface gold mineralization are present at Tin Cup.

- TC21-02 Intersections*:
 - 1.61g/t gold over 66.15m from 64.00m, including
 - 10.07g/t gold over 7.41m from 117.04m and
 - 22.00g/t gold over 2.07m from 122.38m and
 - 29.90g/t gold over 0.65m from 123.30m
- TC21-03 Intersections*:
 - 0.80g/t gold over 170.57m from 59.55m, including
 - 2.32g/t gold over 23.50m from 95.40m

* Intersections are downhole widths as there is insufficient information to calculate true widths at this time.

On March 7, 2022, the Company announced the assay results from the third and fourth drill holes (TC21-04 and TC21-05) completed at the Tin Cup prospect at the Company's 100% owned Secret Pass Gold Project in Mohave County, Arizona.

- TC21-04 Intersections*:
 - 0.95g/t over 103.00m, the entire length of the drill hole from collar to hole bottom, including
 - 2.96g/t over 12.96m from 75.59m
- TC21-05 Intersections*:
 - 0.29g/t over 60.91m from 41.50m, included
 - 0.56g/t over 24.07m from 78.34m, including
 - 4.23g/t over 0.99m from 101.42m, in the last metre of the drill hole

* Intersections are downhole widths as there is insufficient information to calculate true widths at this time.

Revenues

Due to the Company's status as an exploration stage mineral resource company, and a historical lack of commercial production, the Company currently does not have any revenues from its operations, nor does it expect to record any revenue over the course of the next 12 months.

General and Administrative Expenses

The Company incurred a loss and comprehensive loss for the period ended July 31, 2022 of \$139,743 (2021 - \$168,487).

A brief explanation of the significant changes in expense categories is provided below:

- i) Filling and regulatory fees of \$11,509 (2021 – \$8,968) increased due to share activities during the current period.
- ii) Loss on convertible securities of \$26,124 (2021 - \$Nil) related to the fluctuation of the fair value of the common shares issued in advance of conversion to the holder of the convertible securities during the current period.
- iii) Professional fees of \$25,440 (2021 - \$8,630) increased due to general legal services related to the convertible debenture during the current period.
- iv) Promotion and advertisement of \$23,386 (2021 – \$54,938) decreased due to Company's efforts to reduce costs during the current period.
- v) Share-based payments of \$Nil (2021 – \$28,176) decreased due to no options granted and vested during the current period.

Liquidity and Capital Resources

At July 31, 2022, the Company had cash of \$62,323 (April 30, 2022 – \$24,412).

At July 31, 2022, the Company had a working capital deficit of \$959,948 (April 30, 2022 - \$847,417).

The Company expects its current capital resources will not be sufficient to meet its business objectives or day-to-day operations through its next quarter or current operating year, and that its continuation as a going concern will be dependent on its ability to raise additional funds through equity issuances. There is no guarantee the Company will be successful in that regard. See “Overview and Going Concern” above.

Financial Risk Factors

The Company’s financial instruments consist of cash, receivables, accounts payable and accrued liabilities, and convertible securities. The fair value of these financial instruments, other than cash, approximates their carrying values due to the short-term nature of these instruments. Cash is measured at fair value using level 1 inputs.

The Company is exposed to a variety of financial risks by virtue of its activities including currency, credit, interest rate, liquidity and commodity price risk.

a) Currency risk

The Company is exposed to nominal foreign currency risk.

b) Credit risk

Credit risk is risk of financial loss to the Company if the counterparty to a financial statement fails to meet its contractual obligations. The Company's cash is held in large Canadian financial institutions and is not exposed to significant credit risk.

c) Interest rate risk

Interest rate risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The Company is exposed to limited interest rate risk as it only holds non-interest bearing debt.

d) Liquidity risk

Liquidity risk is the risk that the Company will not be able to meet its obligations as they come due. At July 31, 2022, the Company had cash of \$62,323 and current liabilities of \$1,043,187. This emphasizes that the Company's ability to continue as a going concern is dependent on management's ability to raise the required capital through future equity or debt issuances. See "Liquidity and Capital Resources" above. There is no guarantee that the Company will be able to raise capital. The Company manages its liquidity risk by forecasting cash flows from operations and anticipating any investing and financing activities. Management and the directors are actively involved in the review, planning, and approval of significant expenditures and commitments.

e) Price risk

The ability of the Company to explore and develop its exploration and evaluation assets and the future profitability of the Company are directly related to the price of natural resource commodities. The Company monitors these prices to determine the appropriate course of action to be taken.

Related Party Transactions

The Company defines key management personnel as officers and directors.
